## 8.1 Committee Report

The committee met on May 27, shortly after the May classis meeting.

- a. The mandate of the Financial Resources Team, which was adopted by classis in September 2006, calls for financial oversight of the work of the treasurer and also a fundraising component. The Administrative Subcommittee (called AdCom) was asked to review the mandate and membership and report back to CMC.
- b. Synod encouraged each classis to hold a discussion on the Belhar Confession over the course of the next year. CMC decided to hold the discussion at either the January, 2010 or May, 2010 classis meeting. The date and format will be confirmed at CMC's next meeting in November.
- c. The denominational Faith Formation Committee will lead a discussion at the September meeting of classis. The committee looks at how faith is formed in our lives, from childhood through teen, young adult and adult lives. It was suggested that such a discussion be open to the public and set at a stated hour to allow for broader public involvement, perhaps from 1 3 p.m. It should also be promoted with a backgrounder for council discussions. The stated clerk and AdCom will follow up with the Faith Formation presenters and provide proper background information to congregations.
- d. Planned conferences by ministries or individuals. CMC discussed how the wide range of events and conferences held witin classis fit into the Ministry Plan. Should CMC become more proactive in looking at suggested themes for a year? It was suggested that the website, <u>www.classishuron.ca</u>, become the central calendar where all upcoming conferences and retreats are posted, in an effort to avoid having events taking place on the same day. The stated clerk will develop the calendar on the website and encourage its use by classis committees and churches. Upcoming events:

- e. John Vanderburgh was confirmed as new chair of CMC and the Administrative Subcommittee.
- f. Rules for Classis Huron

Classis has operated under the Revised Rules of Classis Huron which were adopted on Sept. 19, 2001. It was only available in hard copy. Over the past eight years, classis adopted a wide range of new policies, procedures and structures.

Over the past year the Revised Rules were retyped electronically and have undergone a thorough revision to bring them up to date. CMC is ready to recommend their provisional adoption by classis, with final adoption to take place at the January 2010 classis meeting.

**MOTION**: That classis send the draft Rules of Classis Huron to the churches and to classis committees, giving them the opportunity to review the document over the next few months, with final approval in January 2010.

## 8.2 Administrative Committee (AdCom)

AdCom, acting in an administrative capacity between meetings of Classis and of CMC, approved the following actions.

- 1. Processed the ecclesiastical credentials for Rev. Jacob Vande Hoef, moving from Guelph First to Brockville CRC.
- 2. Approved Rev. Ray Vander Kooij as counsellor for Guelph First.
- 3. Sent a letter of congratulations to Rev. Roger Gelwicks on occasion of his retirement on August 30.
- 4. Approved the agenda for the September 16 meeting of classis.

## 8.3 Stated Clerk's Report

The stated clerk spends an average of five hours a week on Classis Huron business, mainly responding to email requests and occasional phone calls. Since the May classis meeting, he has engaged in about 150 email conversations, prepared the agenda for and attended the May 27 meeting of the Classis Ministry Committee, prepared the agenda for and attended the August 13 meeting of the Administrative Subcommittee, prepared the agenda for the Sept. 16 classis meeting and connected with guests/presenters.

He has served as a conduit to send out materials to churches within classis on behalf of the denominational office, various denominational committees, stated clerks of other classes and clerks of other churches within classis.

He has also prepared and revised the pulpit supply schedule and remains in regular contact with vacant churches, responding to a wide range of questions having to do with vacancy. He works with the web administrator to keep the classishuron.ca website up to date.

## 8.4 Correspondence

#### **Quad-classis retreat**

Dear Delegates of Classis Huron:

For many years, the pastors and ministry leaders and their spouses of Classis Toronto, Hamilton, and Niagara have gathered together for an annual time of retreat at Muskoka Baptist Conference Centre, near Huntsville. The purpose of this retreat is to give us a time to get away from the regular routines of ministry for a few days and to engage in some personal worship, refreshment, and learning. The conference centre provides a wonderful scenic setting to worship, relax, enjoy the company of peers, be encouraged by an inspirational speaker, and enjoy some delicious food.

At our last retreat (April 2009), as a result of Pastor Bernie DeJonge's invitation to your classis, we were also delighted with the presence of a few pastoral couples from Classis Huron. While there is no formal ecclesiastical authority that plans these retreats (planning rotates voluntarily each year, with each participating classis taking a turn), as planners of this year's retreat, and with the enthusiastic consensus of all the retreat participants, we would like the participation of Classis Huron to become an annual event.

Next year, because a special pastoral spouse retreat has been planned by our denomination during our usual April time period, in 2010 we hope to gather in May. We will inform you as soon as we have the dates, making every effort to avoid weeks when Classis meetings are scheduled. If it cannot be avoided, just for 2010 we may need to ask 2 of our classes to reschedule their meetings.

Last year's cost was \$340 per couple, \$170 per person, and is anticipated to remain at or about the same for 2010. In addition, each of the three classes involved have generously contributed to help reduce the costs of this retreat. The current level of annual support is \$750 per classis. Should you decide to join us, we also ask you to consider supporting this retreat as a classis by adding us to your annual budget. Each year, from 50 to 80 participants attend, which we hope will only increase with the involvement of more pastors and spouses from Classis Huron. On behalf of all pastors, ministry leaders, and their spouses, we look forward to your involvement, and to your support and encouragement! Please let us know of your decision. #### 11.1 Committee Report

This revised CMLT Mandate and Guidelines have incorporated a number of revisions and suggestions which arose at the May Classis meeting. The members of the CMLT consider these to be "friendly amendments" and therefore propose that the motion to accept the mandate and guidelines, tabled at the May meeting, be taken from the table, for discussion and decision, at our September Classis meeting.

The modifications include the following:

- 1. References to SMCC replaced with CRC Candidacy Committee.
- 2. Inserted the link to the Candidacy Committee homepage.
- 3. Replace "synodically approved seminary" with "ATS (Association of Theological Schools) seminary."
- 4. The sentence of #1 under guidelines, regarding EPMC requirements, is taken verbatim from the Candidacy Committee website. Added: "The CMLT requires proof of registration in the EPMC."

**MOTION 1**: That the mandate and guidelines, tabled at the May meeting, be taken from the table, for discussion and decision.

## 11.2 Financial Assistance Guidelines for Churches and Students

## Classis Ministerial Leadership Team of Classis Huron Financial Assistance Guidelines for Churches and Students DRAFT July, 2009

1. Only students who intend to study for ordained ministry in the Christian Reformed Church in North America, and who pursue such studies at an ATS (Association of Theological Schools) seminary, may apply for aid from the Classis Huron Student Assistance Fund. Amounts awarded will be determined by Classis Huron upon the advice of the CMLT; priority will be given to students attending Calvin Theological Seminary. Those who select another seminary for their Master of Divinity program are required to take a special program to orient them to the Christian Reformed Church, called the *Ecclesiastical Program for Ministerial Candidates (EPMC)*. Proof of registration in the EPMC must be submitted to the CMLT.

2. Student aid shall ordinarily be granted via the underwriting of interest free student loans. Should a student discontinue the studies for the ministry of the CRCNA or, once ordained, leave the ministry in the CRCNA within 5 (five) years after their ordination, the student shall repay such grants in accordance with the terms set down in the Agreement and Contract of the CMLT of Classis Huron.

3. All monies granted to students shall be paid out in Canadian funds.

4. Annual re-applications for aid must be submitted by the student to the secretary of the CMLT by March 15. This should be accompanied by a transcript of his/her academic record covering the period since his/her last application. Forms may be obtained from the secretary of the CMLT or from the CRCNA website.

5. It is the student's responsibility to keep the secretary informed about changes of address and changes in vocational goal and approved course of studies.

#### **Agreement and Contract**

#### WITNESSES:

1. That the said Classis Huron grants to the said student \_\_\_\_\_\_ such financial assistance as may be awarded upon the recommendation of the Classis Ministerial Leadership Team.

2. That the said Classis Huron promises and grants this sum of money for but one (1) year at a time. In order to receive continued financial assistance, the student shall renew their application

annually during the month of March on an application form to be requested from the Secretary of the CMLT of the said Classis Huron, which form shall be returned not later than the 15th day of March.

3. That the party of the second part promises and hereby agrees that (s)he will not, while pursuing his/her studies, participate in any activities detrimental to the successful pursuance of his/her studies; that (s)he will, without reservations, submit to the regulations and discipline of the school (s)he attends, and will at all times answer inquiries by the school authorities or by the CMLT of the said Classis Huron concerning his/her studies, daily conduct or spiritual life.

4. The party of the second part furthermore promises and hereby agrees to make full and complete repayment to the said Classis Huron of all monies received, should (s)he discontinue his/her studies for the Ministry of the Word in CRC.

5. The party of the second part furthermore promises and hereby agrees to make repayment if (s)he should leave the ministry in the CRCNA within 5 years after his/her ordination; such repayment will be proportionate to the duration of his/her ministry of the Word in the CRCNA.

6. When repayments under this term and stipulations shall be required, the party of the second part promises and hereby agrees to make repayments at the rate of 20% per year of the original amount owing, which repayments shall begin not later than one year (1) after discontinuing studies for the ministry or leaving the ministry of the CRCNA.

7. Appeal from these stipulations may always and at any time be made to the said Classis Huron, which shall judge whether exceptions shall be allowed and made.

## 11.3 Mandate for the CMLT

Mandate for the Classis Ministerial Leadership Team of Classis Huron DRAFT, July 31, 2009

1. Membership:

It shall consist of three or four members who have a passion for the church's ministry, who are knowledgeable about ordination issues, and who reflect the diversity of classis. No fewer than half of the members shall be Ministers of the Word in the CRCNA.

#### 2. Consultation:

The CMLT will be a consultation and advisory resource to the member congregations of Classis Huron, to Classis itself, and to other interested parties (for instance, Leadership Development Networks) regarding matters related to ministerial candidacy in the CRC.

#### 3. Information:

The CMLT shall provide information and advice to the member congregations of Classis

Huron, to Classis itself, and to other interested parties (for instance, Leadership Development Networks) concerning the candidacy process.

#### 4. Encouragement:

The CMLT shall encourage the member congregations of Classis Huron to be pro-active in identifying possible candidates for ministry in the CRC and offer resources to help people discern their calling.

#### 5. Ministry Readiness Profile:

The CMLT is to provide counsel that will help councils, classis, and those preparing for the ministry in the completion of the individual's Ministry Readiness Profile. Such profiles will be progressive documents testifying to the candidate's development and growth in areas of character, knowledge, and skill. #### 6. Endorsement:

Upon receiving a positive recommendation to enter the candidacy process from an individual's council, the CMLT will interview the individual and work with them to prepare a Financial Plan, as well as a Study Plan or Learning Covenant. The CMLT will then forward their endorsement to the CRC Candidacy Committee. In the case of individuals entering the candidacy or affiliation process through Article 7 or 8, the CMLT will also request licensure on behalf of the individual to the CRC Candidacy Committee.

#### 7. Financial Assistance:

Students applying for acceptance into a Master of Divinity program, as well as students already in such program may apply to the CMLT for classical financial support. The CMLT will recommend to classis and administer the distribution of appropriate financial resources to assist those preparing for minister, following the guidelines of the Classis Huron CMLT.

#### 8. Celebration:

Assist the church and classis that initiated the study/candidacy process in appropriately celebrating the progress of those preparing for the ministry under its care, giving thanks to God for his provision of faithful and gifted leadership for his church.

**MOTION 2**: That the revised mandate and guidelines for the Classis Ministerial Leadership Team as outlined above be approved.

## **12. Nominations Committee**

The only request for nominations to denominational boards is for a new member to the board of trustees for **Calvin College**. This person will represent Region 4 (Chatham, Hamilton, Huron and Niagara). Peter Schuurman has completed his second three-year term and is not eligible for reelection. Nominations of either clergy or nonclergy persons are requested for this position. Any nominations will be forwarded to the denominational office, along with nominees from other classes within the region, for approval by Synod 2010.

The stated clerk has a copy of the position description and Calvin College's mission statement.

## 14.1 Redeemer University College – Dr. Justin Cooper

Greetings from Redeemer University College.

We trust that you have been refreshed after the summer holidays. As we are busy with preparations for the upcoming academic year, which will also mark my last year as president of Redeemer University College, this has been a tremendous time of God's blessing. We are overjoyed with the historic announcement that Redeemer University College will be receiving a \$2.95 million investment from the federal government's Knowledge Infrastructure Program (KIP). This is the largest single grant in Redeemer's history, and marks the first time we have received capital funding from the federal government, together with a number of other Christian universities across Canada. The investment will cover one-half of the total cost of more than 25 different projects which will be undertaken during 2009 and 2010 to refurbish our academic facilities, including upgrading our science labs, enhancing the energy efficiency and sustainability of our academic building (part of which is the installation of solar panels to generate electricity

for our facilities) and renovating the offices for research support, student services and other administrative functions.

Under the Recreation Infrastructure Canada Program (RInC), Redeemer has also received \$600,000 in combined federal and provincial funding, to be matched with \$300,000 through a partnership with the Ancaster Soccer Club (ASC) for a significant upgrade to our existing soccer field. We are also awaiting confirmation of additional federal/provincial funding of \$2 million toward a second soccer complex that would include a "bubble" for year-round use, again in cooperation with ASC and the City of Hamilton. This is also the first time we have received provincial funds, which come to us from a non-educational fund. Such funding underscores a sense of recognition of Redeemer's community contribution.

We are encouraged by the positive outlook for our 2009-10 fall enrolment and housing targets, now projected for 847 full-time students and 425 students in residence. Our favourable Maclean's ratings, active admissions website, the prospect of fewer jobs in an economic downturn and the hard work of our recruitment personnel are all plausible reasons for these good projections. We also pleased to announce two senior administrative appointments: Richard Wikkerink as Associate Vice-President, Student Development and Registrar; and Doriel Moulton as Associate Vice-President, Marketing.

We look forward to their leadership and contribution to Redeemer. We will also seek to fill two faculty positions this year, in philosophy and in psychology. We also said farewell to Dr. Wayne Norman, who retired after 21 years as Professor of Psychology and Director of Research and Faculty Development.

Launching of the new Cornerstone Program to as a replacement for the Redeemer Foundation is planned for September 25, also the date of our faculty artists concert. Redeemer's annual membership meeting will be held on Friday, November 6, in conjunction with a concert by Dr. Paul Thorlakson and Valerie Tryon. Please

reserve these dates. We also look forward to this year's Zylstra Lectures on November 11, 2009 by Dr John Witte, Jr., director, Centre for the Study of Law and Religion at Emory Law School in Atlanta, Georgia.

Please note that Tuesday, March 2, 2010 is Redeemer's annual Ministers' Conference, with the speaker yet to be announced. Please check our website at www.redeemer.ca for updates about events, lectures and concerts.

We have a sense of excitement as we continue to work on developing a special legacy fundraising campaign in preparation for my retirement at the end of June 2010, focussing on student aid, faculty research and debt reduction. The Presidential Search Committee is proceeding effectively with their process to find a new president. Please pray for this process as they seek the person of God's choosing.

Thank you for your continuing support of Redeemer through prayer and financial giving. Church donations for the past fiscal year were \$814,000, which exceeded our expectations! These gifts are essential for our \$1.6 million student financial aid program, which will now be funded by church donations and the Cornerstone Program, making a Christian university education accessible to more students. We praise God for his

faithfulness and wonderful blessings.

## 15. Treasurer's Report -- Cindy Tamming

The attached budget is for your consideration at the upcoming meeting. The following are the noted items of change:

- 1. The Classical Ministry Committee line was previous named Classical Interim Committee. Its budget increase is due to the combination of two previous committees into one. There is a reduction made in the Special Committees expenses to offset for this change.
- 2. The Church Plant classical ministry share was increased \$1.00.
- 3. The Student Fund ministry share has been increased to \$9.70.

**MOTION 1**: That the proposed budget for 2010 be adopted as presented.

Also, the Rules of Classis Huron state that the treasurer, "through the budget, propose and have adopted the following items annually".

#### **MOTION 2**: That Classis adopt the following for 2010:

- 1. That the rates for a church service be held at \$80.00 per service, no change.
- 2. That the driving expense reimbursement be kept at the rate of \$0.50, no change.
- 3. That the host church be reimbursed \$500.00, no change.

4. That the remuneration for loss of wages while conducting the business of Classis remain at \$150.00 per day for up to five (5) per week, no change.

5. That the honorarium for the Stated Clerk to be increased to \$3,000 (from \$2,500) and for the Treasurer to \$3,000 (from \$2,500).

The Guelph and Waterloo Campus Ministry budgets have been included for your information. The amount to be approved by Classis is listed at the bottom of the Classical budget.

After these have been approved, a full list of Classical and Denominational Ministry Shares will be sent to all churches of Classis Huron.
