8. Classis Ministry Committee -- Rev. John Vanderburgh

8.1 Committee Report

The Classis Ministry Committee (CMC), consisting of representatives of all of the ministries/committees of classis, met on February 8 in Listowel.

It agreed to create a spring training event for exhorters and others which will take place on May 21 at Community CRC, Kitchener. Rita Klein-Geltink and Darren Roorda are coordinating the event.

The committee continues to work on the 2010 - 2013 Classis Huron Ministry Plan, merging committee goals and objectives into the overall plan.

In response to repeated requests on church credentials, CMC agreed to hold a young adult ministry panel discussion at the May meeting of classis with a focus on "What are young adults looking for and how can we as churches respond?" A discussion continues to take place on the role and job description of the classis prayer coordinator. The Home Missions Committee will come to the next CMC meeting with a proposed job description. The current prayer coordinator, Rev. Jack Quartel, is retiring from the position.

CMC was asked by classis to review its decision concerning licensing of new exhorters, and to encourage the use of gifts within classis. In the discussion it was pointed out that there are currently seven exhorters and two vacancies. Existing exhorters will continue to have their licenses renewed, pending a positive review. Those with a desire to preach can still do so within the confines of their own congregations, with their council's approval. CMC decided to stick with its recent decision (ie: there is currently no need for additional exhorters). The practice is need-based and will be reviewed regularly by CMC.

Rev. Ray Vander kooij was appointed mentor to Rev. Andrew Vis in Orangeville for the next five years.

A discussion on funding of campus ministries, and their related cash-flow concerns resulted in arranging a meeting involving representatives from the two campus ministries with the Financial Resources Team to deal with those concerns. It was noted that CMC members are directors of the corporation of Classis Huron of the CRCNA and are covered through \$5 million of liability whenever they act on behalf of classis.

8.2 AdCom (Administrative Committee)

AdCom is the executive committee of CMC. Its primary tasks are to set the agendas of meetings of CMC and of classis, and to act on behalf of classis between meetings.

AdCom met in February to set the agenda of the February meeting of CMC. It provides oversight of the work of the stated clerk and acts as a sounding board and advisor as he deals with various requests for information.

AdCom met in April to approve the agenda for the May meeting of classis, approving the list of presenters to classis. They also served as the Exhortation Licensing Review Committee to process the congregational evaluations and the sermon review for John Zwart's renewal of his license to exhort.

8.3 Stated Clerk's Report

Since the January meeting of Classis, the stated clerk engaged in more than 200 email and telephone conversations, mainly with church councils and pastors within classis. Among the highlights:

- Prepared the minutes of the January 2011 classis meeting and the various details that flowed out of that meeting.
- Reported the slate of synodical delegates to Synod 2011 to the denominational office, and provided the necessary paperwork.
- Responded to requests from new-to-classis ministers concerning the process to receive their provincial licenses to marry.
- Provided a classis representative to the January 28 installation service for Rev. Andrew Vis in Orangeville.
- Corresponded with vacant and soon-to-be vacant churches concerning their need for pulpit supply and the rules governing eligibility for pulpit supply.
- Arranged for a mentor for Rev. Andrew Vis.
- Engaged in various conversations with the chairs and clerks of church councils concerning various questions about process and conflict.
- Numerous email conversations concerning the creation of a young adult ministry panel discussion at classis.
- Numerous emails concerning the renewal process for the license to exhort for John Zwart.
- Conversations with Blyth council concerning the leave of absence and release of ministry for Rev. John Kuperus.
- Conversations with synodical deputies concerning the release of ministry of Rev. John Kuperus.
- Various conversations with the denominational office and the staffs of various denominational ministries.
- Conducted the annual review and renewal process to provide liability insurance coverage for the directors of Classis Huron.
- Regularly connecting with various ministry/committee leaders and with those in leadership at vacant churches.
- Created the agendas for meetings of AdCom and CMC and attended those meetings. Attending the meeting involving the Financial Resources Team and representatives of the two campus ministries.

MOTION: That the work of the Classis Ministry Committee, AdCom and Stated Clerk be approved.

8.4 Renewal of license to exhort for John Zwart

Sermon evaluation by Bill Hoogland, Ralph Wigboldus.

Review of congregational evaluations by AdCom which leads to the following recommendation:

MOTION: That a license to exhort for John Zwart be extended for a five-year term, ending May, 2016.

9. Correspondence

9.1 Guelph First CRC (Request for early retirement for Rev. Bernard de Jonge)

Synod 2011 will debate a revision of the Ministers Pension Plan provisions, changes driven by a Canadian government requirement that pension plans be fully funded. The options presented in the letter from the Ministers Pension Plan office in Grand Rapids suggest the merits of early retirement contrasted with staying in the program until the new retirement age of 66.

Having considered the options, Rev. Bernard de Jonge formally requested early retirement, effective June 30, 2011. Council granted that request and asks the concurrence of Classis Huron.

MOTION: That Classis Huron grant Rev. Bernard de Jonge's request for early retirement, effective June 30, 2011. Grounds:

- 1. Personal health and family considerations.
- 2. The proposed new pension plan arrangements effective July 1, 2011 will negatively affect spousal support.

9.2 Request from Rev. John Kuperus to be released from ministry at Blyth CRC.

The council of Blyth Christian Reformed Church received a formal request from their pastor, Rev. John Kuperus, last summer to be released from ministry at Blyth CRC (Article 17a), effective September 30, 2010.

At the September 2010 meeting of classis, upon advice of the synodical deputies, this request was withdrawn and Blyth council was encouraged to provide Rev. Kuperus with a leave of absence.

Rev. Kuperus was enrolled in a mission-focused, 20-week course with Youth With A Mission in Hawaii, including a time of overseas mission experience. He is currently staffing the Crossroads Discipleship Training program in Hawaii for a three month term.

Rev. Kuperus once again requests that he be released from ministry at Blyth CRC via Article 17a. He believes that his ministry in Blyth has been completed and he is pursuing ministry opportunities, both within established Christian Reformed Churches and elsewhere.

Council once again seeks Classis Huron's approval of his request as well as the concurring advice of the synodical deputies.

MOTION: That Classis Huron approves of the release of Rev. John Kuperus from active ministerial service in Blyth CRC, through action initiated by Rev. Kuperus, as per Article 17a, effective May 31, 2011. Grounds:

- 1. Rev. Kuperus received a 20-week leave of absence from Blyth CRC, effective October 1, 2010, to pursue a course with Youth With A Mission in Hawaii.
- 2. Rev. Kuperus has concluded his leave of absence and is currently actively pursuing ministry opportunities within established churches and elsewhere.
- 3. Rev. Kuperus has requested that he be released from ministry at Blyth CRC.

NOTE: The synodical deputies are required to concur with the decision of classis.

10. Synod 2011: What's on the agenda?

Delegates to Synod will lead a discussion on some of the significant and not-so-significant items which will appear in the Agenda for Synod. Delegates to classis are urged – if at all possible – read through the Agenda for Synod prior to the meeting.

11. Overture -- Decry the work of Calvin professors - Collingwood CRC

We, the consistory of the Collingwood Christian Reformed Church overture Classis Huron to decry in the strongest possible terms the works of Calvin professors Schneider and Harlow (published in Perspectives on Science and Christian faith). We request Classis Huron to make known to Synod the abhorrence of the professors' articles and their reflection on the Christian Reformed Church belief's doctrines and confessions.

Grounds:

- 1. We confess that the Old and New Testaments are the word of God, and only infallible rule of faith and life.
- 2. The professors' writings clearly and unequivocally deny our confessions in the Heidelberg Catechism, the Belgic Confession and the Canons of Dort.
- 3. The two writers have clearly overstepped the bounds of the form of subscription.

MOTION: That Classis adopt the overture from Collingwood CRC.

12. Classis Ministry Leadership Team (CMLT) – Rev. Rita Klein-Geltink

MOTION 1: To close and dispose of the files of those who have fulfilled the obligations of their CMLT (formerly the Classis Student Fund) contracts.

Grounds:

- 1. Loans to seminary students are forgiven after 5 years of full time ordained service to the CRC.
- 2. The files may include confidential information which is no longer relevant or necessary for use by the CMLT.

MOTION 2: To cease efforts to recover the outstanding student loans of four people.

Grounds:

- 1. These people have not met the contractual requirement of items 4, 5, and 6 of the CMLT/Student contract (see below).
- 4) The party of the second part furthermore promises and hereby agrees to make full and complete repayment to the said Classis Huron of all monies received, should (s)he discontinue his/her studies toward ordained ministry.
- 5) The party of the second part furthermore promises and hereby agrees to make repayment if (s)he should leave the ministry in the CRCNA within 5 years after his/her ordination; such repayment will be proportionate to the duration of his/her ordained ministry in the CRCNA.
- 6) When repayments under this term and stipulations shall be required, the party of the second part promises and hereby agrees to make repayments at the rate of 20% per year of the original amount owing, which repayments shall begin not later than one year (1) after discontinuing studies for the ministry or leaving the ministry of the CRCNA.
- 2. There is little chance of recovering these funds due to the financial situation of the individuals.

15.3 Redeemer University College

Greetings once again from Redeemer University College. In this Lenten Easter season, we trust that you will know the grace and hope that we have in the resurrection of our Saviour and Lord Jesus Christ.

It is amazing to realize that we are near the end of another academic year. Redeemer has been truly blessed with an outstanding year. With record enrolment, our classrooms and residences have been full and lively. And with the help of generous donors, including outstanding support this year from the CRC classes, we are on track to finish 2010-11 with a balanced budget, and we are planning for another balanced budget in 2011-12.

Many special events on campus have made Redeemer a vibrant place and become an increasingly influential leader of Christian learning in Canada. Some examples: Dr. Steven Garber as speaker for our "The World and Our Calling" Lecture; a "Theo Plantinga Festschrift" book launch in memory of the work of former Redeemer Philosophy professor, Dr. Theo Plantinga; our "Faith and Social Justice" conference with Greg Paul as keynote speaker; and in collaboration with the Paideia Centre, Dr. Jonathan Chaplin for the launch of his new book on Herman Dooyeweerd; Christian Philosopher of State and Civil Society. We also hosted the Annual Ministers' Conference with Rev. Wesley Granberg-Michaelson, Secretary of the Reformed Church of America, as speaker and with excellent participation of pastors from many denominations. Our community has also enjoyed several art exhibits, choir concerts and plays at Redeemer. Our CLEAR program offerings for Winter and Spring were featured in a full page ad in the Hamilton Spectator with follow up ads each week promoting weekly lecture and workshop startups. We hope to offer courses across the province in

Our students have been very active both in their courses and outside of classes. During our February Reading Break, student teams served on mission trips to down-town Hamilton, Amsterdam, and Mexico, and in many other ways demonstrated our commitment as hands and feet of Christ's body. Student-athletes at Redeemer have been working

Ottawa, Ancaster, and Windsor for the Summer Institute for Continuing Teacher Education.

extremely hard this semester and the results have been positive. Our Badminton team advanced to the Provincial Championships in 3 events out of 5. The Men's Volleyball won the Silver Medal at the Provincial OCAA championships, doing so with a beautiful demonstration of Christian sportsmanship. Planning is underway to incorporate the new soccer dome into both varsity and campus recreation programming.

Our KIP and RInC projects remain ongoing and preparations for installing the roof-top solar panels continue. Construction of the soccer complex also continues and we are grateful for the extended deadlines from March 31 to October 31, 2011 from the federal and provincial governments for completion of KIP and RInC projects.

We are encouraged and hopeful in our planning for next year. New student interest continues to be very strong and we hope to have enrolments next year at or above this year's record levels. This winter for the first time, our Recruitment staff attended transfer fairs at community colleges and visited with youth pastors at a number of churches.

We also thank God for bringing excellent new faculty to fill vacant positions at Redeemer. So far, we have appointed Ms Laura Luchies in Psychology, Mr Philip Teeuwsen in Education, and Mr. Ben Dunson for a two-year sessional position in Religion and Theology. We also are interviewing for a tenure stream position in English and a sessional position in French.

We have started a Succession Planning Process to prepare for searches to replace our Vice President Administration and Finance and Vice President, Advancement, who will retire in June 2012, and our Vice President, Academic, who will retire in June 2013

As we work to complete the tasks for the 2010-11 academic year, we thank God for the many ways that He is blessing us with strong enrolment, gifted and committed faculty and staff, and dedicated and generous donors. We are especially grateful for the support of our churches – please convey our thanks to your congregations for their prayers and financial support of Redeemer. Their partnership is crucial as we pursue our mission of lifting up the Name of Christ in university education through teaching, scholarship and service.

Our theme for the year, "Pray Without Ceasing", reminds us that we depend on God's faithful and loving hand, and that we are called to live out of the reality of His kingdom. We have indeed seen God at work throughout this academic year. May He continue to bless, guide, and encourage your church congregations and Redeemer in our faithfulness and service together.

16. Financial Resources Team -- Clarence Louter

In March, the Finance Resources Team met with representatives from both Guelph and Waterloo campuses to raise awareness of the financial issues that the Campus Ministries are dealing with. With the ongoing reduction of Home Mission support, the growing need to raise third stream funding, and the timing of the Classical Ministry Shares payments in respect to the payout of monthly ministry expenses, the campuses have felt a heavy financial strain at various times during their more active periods of ministry.

The Finance Resources Team is currently working with the campus ministries to come up with solution to this ongoing campus cash flow problem which occurs generally during the months of October to March. While there were a few suggestions as to how to resolve the issue in the short term, there needs to be further investigation into a more permanent solution. During the next several months, the Financial Resources Team will continue work with the two campuses to find a more suitable solution.
